Letter dated 27 July 2016 from the Permanent Representatives of Angola, Egypt, Japan, Malaysia, New Zealand, Senegal, Spain, Ukraine, Uruguay and Venezuela (Bolivarian Republic of) to the United Nations addressed to the President of the Security Council

We, the undersigned, as Chairs of Security Council sanctions committees, have agreed on the document attached hereto, which outlines an administrative delineation of Security Council sanctions committee correspondence (see annex). The document is designed to reduce administrative burdens and increase the working efficiencies of the Chairs and of the Secretariat staff providing secretarial support to the sanctions committees. Unless otherwise indicated by individual Chairs, it will form the basis of the administrative delineation of Security Council sanctions committee correspondence between the Chairs and the committee secretaries.

As always, regular conversations between the Secretary and the Chair will need to be held about prospective committee correspondence. Where correspondence is not captured in the document or is potentially sensitive in nature, judgment will need to be exercised.

We would be grateful if you could have the present letter distributed as a document of the Security Council.
