ADOPTION OF THE AGENDA OF THE TENTH REGULAR SESSION AND ALLOCATION OF ITEMS TO COMMITTEES, AND ORGANIZATION OF THE SESSION

Report of the General Committee

The General Committee, at its 102nd meeting held on 21 September 1955, 1. considered the memorandum of the Secretary-General on the organization of the tenth regular session (A/BUR/140) and began consideration of the provisional agenda (A/2915), the supplementary list of items (A/2942) and the request by India for the inclusion of an additional item (A/2949 and Add.1), as contained in the memorandum of the Secretary-General relating to the adoption of the agenda and allocation of items to Committees (A/BUR/141). The consideration of the latter memorandum was completed at the 103rd meeting held on 22 September 1955. The General Committee decided to recommend to the General Assembly that 2. item 18 of the provisional agenda, "The International Conference on the Peaceful Uses of Atomic Energy: report of the Secretary-General" and item 6 of the supplementary list, "Progress in developing international co-operation for the peaceful uses of atomic energy: reports of Governments" should be included in the agenda as sub-items (a) and (b) under a general heading "Peaceful uses of atomic energy".

3. The General Committee further decided to recommend that item 4 of the supplementary list, "Co-ordination of information relating to the effects of atomic radiation upon human health and safety" and the additional item proposed by India, "Dissemination of information on the effects of atomic radiation and on the effects of experimental explosions of thermo-nuclear bombs" should be included in the agenda as sub-items (a) and (b) under a general heading "Effects of atomic radiation".

4. The General Committee decided, by 7 votes to 4, with 4 abstentions, to recommend that item 1 of the supplementary list, "Application, under the auspices of the United Nations, of the principle of equal rights and self-determination of peoples in the case of the population of the Island of Cyprus", should not be included in the agenda.

5. The General Committee decided, by 8 votes to 5, with 2 abstentions, to recommend that item 3 of the supplementary list, "The question of Algeria", should not be included in the agenda.

6. With regard to item 5 of the supplementary list, "The question of West Irian (West New Guinea)", the President stated that the interested parties had informed him that they wished the discussion on the inclusion of this item to be postponed for a few days. The General Committee agreed, without objection, to take up this question at a later date.

7. The General Committee decided to recommend the inclusion in the agenda of item 7 of the supplementary list, "Establishment and maintenance of a United Nations Memorial Cemetery in Korea", the representatives of the Union of Soviet Socialist Republics and of Poland requesting that their abstentions be recorded.

8. Statements were made with respect to the inclusion of items 20 and 23 of the provisional agenda; $\frac{1}{}$ after discussion, it was decided to recommend these items for inclusion. The remaining items were recommended for inclusion without discussion.
