QUESTION OF THE VIOLATION OF HUMAN RIGHTS IN THE OCCUPIED ARAB TERRITORIES, INCLUDING PALESTINE

Note by the Secretary-General

- 1. In paragraph 6 of its resolution 1989/2 A, the Commission on Human Rights requested the Secretary-General to provide it with all United Nations reports appearing between sessions of the Commission that deal with the conditions in which the population of occupied Palestine are living.
- 2. The Secretary-General accordingly draws the attention of the Commission to the United Nations reports listed hereunder, which have been issued since the closure of its forty-fifth session on 10 March 1989. Any reports issued after the preparation of this note will be included in an addendum.
