Statement

"Implementing the post-2015 development agenda: moving from commitments to results"

The Young Professionals Forum welcomes the 2016 ECOSOC High Level Segment theme "Implementing the post-2015 development agenda: moving from commitments to results", and the adoption of the post-2015 development agenda by the President of the General Assembly September 2015.

We express our satisfaction to the declaration, vision, principles and commitments to the new agenda, means of implementation, call for action and the sustainable development goals and targets. 2016 theme "moving from commitment to results" expresses hope that the principles and commitments that have been made by all stakeholders will truly reflect in the actions that will help the post-2015 development agenda to be achieved.

Achieving the post-2015 development agenda, will depend on a solid foundation built on collaboration and partnership with different government agencies, public and private sector, civil society and Non-governmental organizations, this will help to foster and encourage participation in positively engaging in the call to action to produce results.

The post-2015 development agenda as adopted by the President of the General Assembly has "The new Agenda" which announced the 17 Sustainable Development Goals with 169 associated targets which are integrated and indivisible. The world leaders have pledged common action to collaboratively work together in the pursuit towards achieving sustainable development.

Young Professionals Forum expresses it appreciation to world leaders for making this commitment, and also wishes that the world leaders will be serious and follow the call to action and implement the post-2015 development agenda whole heartedly.
