QUESTION OF ASSISTANCE TO LIBYA: REPORT OF THE SECRETARY-GENERAL

### Report of the Second Committee

Rapporteur: Mr. Janez STANOVNIK (Yugoslavia)

- 1. The General Assembly, at its 530th plenary meeting on 30 September 1955, allocated to the Second Committee item 26 of the agenda "Question of assistance to Libya: report of the Secretary-General".
- 2. The Committee devoted two meetings (A/C.2/SR.384 and 385) to this item and eight delegations took part in the debate. With the agreement of the Committee, the representative of the United Kingdom of Libya participated in the discussion.
- 3. The Committee, at its 384th meeting, received a joint draft resolution (A/C.2/L.275) submitted by Egypt, Iraq, Lebanon, Pakistan, Saudi Arabia, Syria and Yemen.
- 4. At the 385th meeting, the Committee adopted this joint draft resolution unanimously.
- 5. The Second Committee therefore recommends to the General Assembly the adoption of the following draft resolution:

#### QUESTION OF ASSISTANCE TO LIBYA

### The General Assembly,

Recalling the part played by the United Nations in the creation of the independent State of the United Kingdom of Libya, in accordance with General Assembly resolution 289A (IV) of 21 November 1949 recommending that Libya, comprising Cyrenaica, Tripolitania and the Fezzan, should be constituted as an independent and sovereign State, and that this independence was achieved on 24 December 1951, in accordance with that resolution,

Recalling General Assembly resolution 515 (VI) of 1 February 1952 by which the Assembly requested the Economic and Social Council to study, in consultation with the Government of the United Kingdom of Libya, ways and means by which the United Nations, with the co-operation of all Governments and the competent specialized agencies, and upon the request of the Government of Libya, could furnish additional assistance to the United Kingdom of Libya with a view to financing its fundamental and urgent programmes of economic and social development, giving consideration to the possibility of opening a special account of voluntary contributions to that end, and to report thereon to the General Assembly at its seventh session,

Recalling further its resolution 529 (VI) of 29 January 1952 on the problem of war damages in Libya,

Recalling General Assembly resolution 398 (V) of 17 November 1950 which recognizes the special responsibility assumed by the United Nations for the future of Libya,

Having noted the communication (A/2969) dated 1 September 1955 from the Prime Minister of Libya, addressed to the Secretary-General,

Having noted the report (A/2968) of the Secretary-General on the question of assistance to Libya.

Noting with satisfaction the technical assistance given to the United Kingdom of Libya under the United Nations technical assistance programmes, in accordance with General Assembly resolution 726 (VIII) of 8 December 1953,

Noting that there has been no material response to the invitation in paragraph 1 of resolution 726 (VIII),

- 1. Invites anew all Governments willing and in a position to do so to provide financial assistance to the United Kingdom of Libya through the appropriate mechanisms within the United Nations Organization available for receiving voluntary contributions, in order to assist Libya in the financing of its fundamental and urgent programmes of reconstruction and of economic and social development;
- 2. Recommends that, if and when further means become available for assisting in the financing of the development of under-developed areas, due consideration be given by the United Nations and the specialized agencies to the specific development needs of Libya;

- 3. Requests the Secretary-General and the specialized agencies concerned to continue to waive local costs and to give all possible favourable consideration to the requests of Libya for technical assistance, taking into account the special needs of Libya and the principles of the technical assistance programmes of the United Nations and the specialized agencies enumerated in Economic and Social Council resolution 222 (IX) of 15 August 1949;
- Requests the Secretary-General to bring the present resolution to the attention of the Governments of Members and to take the necessary measures to facilitate the implementation of paragraph 1 above;
- 5. Requests the Secretary-General to make a special report on the question of United Nations assistance to Libya in time to be placed on the agenda of the thirteenth session of the General Assembly.
