MANIFESTATIONS OF RACIAL PREJUDICE AND NATIONAL AND RELIGIOUS INTOLERANCE

Note by the Secretary-General

- 1. As requested by the General Assembly in resolution 1779 (XVII), entitled "Manifestations of racial prejudice and national and religious intolerance", the Secretary-General presented to the Assembly at its eighteenth session a report (A/5473 and Add.1 and 2) on action taken by Governments, specialized agencies and the non-governmental organizations concerned in compliance with the resolution.

The report contained information submitted by the Governments of the following States: Argentina, Austria, Brazil, Bulgaria, Burma, Byelorussian Soviet Socialist Republic, China, Denmark, El Salvador, Federation of Malaya, Finland, France, Greece, Guinea, Hungary, Iran, Iraq, Ireland, Italy, Jamaica, Japan, Jordan, Luxembourg, Madagascar, Nepal, Netherlands, New Zealand, Nicaragua, Niger, Peru, Philippines, Portugal, Sierra Leone, Sudan, Sweden, Syria, Tanganyika, Ukrainian Soviet Socialist Republic, United Arab Republic, United Kingdom of Great Britain and Northern Ireland and Venezuela (A/5473); Australia, Canada, Czechoslovakia, Israel, Nigeria, Poland, Romania and Union of Soviet Socialist Republics (A/5473/Add.1); Ireland (supplementary information) and Uganda (A/5473/Add.2). The report also included information received from the International Labour Organisation and the United Nations Educational, Scientific and Cultural Organization (A/5473); and from the following non-governmental organizations: International Catholic Press Union, International Council of Women, International Humanist and Ethical Union, World Jewish Congress, World Veterans Federation (A/5473), Friends World Committee for Consultation, International

Federation of University Women, International League for the Rights of Man, World Union of Catholic Women's Organizations (A/5473/Add.1), Consultative Council of Jewish Organizations and International Council of Women (A/54/Add.2).

- 3. The General Assembly at its 1279th plenary meeting, on 12 December 1963, approved the recommendation of the Third Committee to postpone consideration of the item, "Manifestations of racial prejudice and national and religious intolerance" to the nineteenth session.
