Addendum

1. At its 1208th plenary meeting, on 13 December 1972, the General Assembly approved the calendar of conferences and meetings of the United Nations for 1973 contained in annex I of the Secretary-General's report (A/8790 and Add.1 and 2), in which it was indicated (A/8790/Add.1, para. 3) that an addendum would be issued to reflect any modifications required by subsequent decisions of the General Assembly.
2. The present addendum reflects those modifications only in terms of those organs that have been extended and new organs established by the General Assembly and other modifications properly brought to its attention during the twenty-seventh session.
