ELECTION OF MEMBERS OF THE INTERNATIONAL LAW COMMISSION
ADDITIONAL LIST OF CANDIDATES NOMINATED BY MEMBER STATES
Note by the Secretary-General

- 1. By resolution 1647 (XVI) of 6 November 1961, the General Assembly increased the membership of the Commission from twenty-one to twenty-five. In consequence of this enlargement of the Commission, the General Assembly decided, by the same resolution, to request the Secretariat, by way of exception, to include in the list of candidates in the election to be held at the current session, which list, in accordance with article 5 of the Commission's Statute, had been closed on 1 June 1961, such names as would have been communicated to it in writing before 15 November 1961.
- 2. The Secretary-General has the honour to set forth below, for the information of Members of the United Nations and of the General Assembly, an additional list of candidates nominated by Member States pursuant to the above-mentioned resolution.

 3. The Secretary-General also has the honour to inform States Members of the United Nations and the General Assembly that the Government of Greece has notified him that it has withdrawn its nomination of Mr. Constantin EUSTATHIADES, and that the Government of the Netherlands has withdrawn its nomination of Mr. A.J.P. TAMMES and the Government of Spain that of Mr. Camilo BARCIA TRELLES.
