

REQUESTS FOR THE INCLUSION OF  
ADDITIONAL ITEMS IN THE AGENDA

Report of the General Committee  
to the General Assembly

The General Committee, at its twenty-fourth and twenty-fifth meetings held on 5 and 6 November, considered eight requests for the inclusion of additional items in the Agenda of the second part of the first session of the General Assembly.

1. Translation and publication  
of the Classics. (A/BUR/47):

Proposal of the  
Delegation of Lebanon

The General Committee recommends to the General Assembly:

- (a) that this item be included in the Agenda  
(b) that it be referred to the Third Committee for consideration and report to the plenary meeting

2. Increase in the membership  
of the Economic and Social  
Council. (A/BUR/48):

Proposal of the  
Delegation of Argentina

The General Committee reports to the General Assembly that the representative of Argentina, who, in accordance with Rule 34 of the Provisional Rules of Procedure, was present during the discussion of this item, has decided to re-submit the item for inclusion in the provisional agenda of the next session of the General Assembly.

3. Revision of Item 15 of the  
Agenda. (A/BUR/49):

Proposal of the  
Delegation of the United  
States of America

The General Committee recommends that the General Assembly approve the revision of Item 15 of the Agenda as follows:

Report of the Headquarters Commission and consideration of possible alternative sites for permanent headquarters in the New York area and in the San Francisco Bay area which may be available without cost or at reasonable cost; and appointment of a Planning Commission of Experts (Resolution of 14 February 1946).

4. Resolution on the Crime of Genocide: Proposal of the Delegations of  
(A/BUR/50) Cuba, India and Panama

The General Committee recommends to the General Assembly:

- (a) that this item be included in the Agenda.
- (b) that it be referred to the Sixth Committee.

5. Creation by the United Nations Proposal of the Delegation  
of Advisory Boards: (A/BUR/52) of Lebanon

The General Committee recommends to the General Assembly:

- (a) that this item be included in the agenda
- (b) that it be referred to the Second and Third Committees  
for consideration of its economic and social aspects respectively.

6. Creation of a World University Proposal of the Delegation  
Alliance: (A/BUR/53) of Lebanon

The representative of Lebanon, who was present during the discussion of this item, has decided to re-submit this item for inclusion in the provisional agenda of the next session of the General Assembly.

7. Resolution on the holding of a Conference Proposal of the Delegation  
to implement the provision of Chapter XI of the Philippine Republic  
of the Charter regarding non-self-governing  
territories: (A/BUR/54)

The General Committee recommends to the General Assembly:

- (a) that this item be included in the agenda
- (b) that it be referred to the Fourth and Sixth Committees simultaneously

8. Resolution on Persecution and Proposal of the Delegation  
Discrimination: (A/BUR/51) of Egypt

During the course of the discussion of this item the Egyptian representative, who was present, amended the text of his proposal by deleting the preamble to the resolution and the words "in those areas" in the last paragraph. He requested that the General Assembly should be asked to consider this item without reference to a Committee.

The result of the vote taken in the General Committee on the above amended proposal was as follows:
