APPOINTMENT TO FILL VACANCIES IN THE MEMBERSHIP OF SUBSIDIARY BODIES OF THE GENERAL ASSEMBLY

ADVISORY COMMITTEE ON ADMINISTRATIVE AND BUDGETARY QUESTIONS

Note by the Secretary-General

1. The rules of procedure of the General Assembly provide that:

"Rule 156

"The General Assembly shall appoint an Advisory Committee on Administrative and Budgetary Questions (hereinafter called the "Advisory Committee"), with a membership of nine, including at least two financial experts of recognized standing."

"Rule 157

"The members of the Advisory Committee, no two of whom shall be nationals of the same State, shall be selected on the basis of broad geographical representation, personal qualifications and experience, and shall serve for three years corresponding to three financial years, as defined in the regulations for the financial administration of the United Nations. Members shall retire by rotation and shall be eligible for reappointment. The two financial experts shall not retire simultaneously. The General Assembly shall appoint the members of the Advisory Committee at the regular session immediately preceding the expiration of the term of office of the members, or, in case of vacancies, at the next session."

2. The present membership of the Committee is as follows:

3. At its tenth session, the General Assembly (resolution 959 (X) of 29 November 1955) appointed the following to be members of the Committee for a three-year term, commencing on 1 January 1956:

Mr. Carlos Blanco;

Mr. Arthur H. Clough;

Mr. John E. Fobes.

At its twelfth session, the General Assembly was informed of the resignation of Mr. Arthur H. Clough. The General Assembly (resolution 1194 (XII) of 13 December 1957) appointed Mr. A.H.M. Hillis for a one-year term, commencing on 1 January 1958, to fill the unexpired term of office of Mr. Clough.

- 4. Since the terms of office of Mr. Blanco, Mr. Fobes and Mr. Hillis are due to expire on 31 December 1958, it will be necessary for the General Assembly, at its thirteenth session in 1958, to appoint three persons to fill the resulting vacancies. The members so appointed will serve for a period of three years, commencing 1 January 1959.
- 5. At previous sessions, the Fifth Committee, after a secret ballot, has submitted to the General Assembly a draft resolution containing the names of the persons recommended for appointment. It is suggested that a similar procedure should be followed at the thirteenth session.
