OPERATIONAL ACTIVITIES FOR DEVELOPMENT

Report of the Second Committee

Rapporteur: Mr. Mohamed WARSAMA (Somalia)

1. At its 1758th meeting, on 20 September 1969, the General Assembly allocated to the Second Committee agenda item 45 entitled:

"Operational activities for development:

- (a) Activities of the United Nations Development Programme: reports of the Governing Council;
- (b) Activities undertaken by the Secretary-General."

2. The Committee considered this item at its 1279th to 1282nd meetings, held on 13 and 14 November 1969. At the 1279th meeting, the Committee heard statements by Mr. Paul G. Hoffman, Administrator of the United Nations Development Programme, and by Mr. Victor Hoo, Commissioner for Technical Co-operation. $\frac{1}{2}$

4. At its 1282nd meeting, the Committee took note of the reports of the Governing Council on its seventh and eighth sessions (see paragraph 8 below, draft resolution I).

5. The Committee unanimously approved the draft resolution on procedures for implementation of new arrangements for regional and inter-regional projects under the Technical Assistance component of the United Nations Development Programme, which had been recommended by the Economic and Social Council in its resolution 1432 (XLVII) (see paragraph 8 below, draft resolution II).

6. At the same meeting, the Chairman orally proposed a draft resolution concerning programme and budgetary procedures for part V of the United Nations budget. The proposed resolution took into account certain of the procedures recommended by the Economic and Social Council in its resolution 1434 (XLVII) and the draft resolution which the Committee had approved at its 1275th meeting, under item 38, concerning the regular programme of technical assistance for industrial development.⁴/

8. The Second Committee therefore recommends to the General Assembly the adoption of the following draft resolutions:

DRAFT RESOLUTION I

Reports of the Governing Council of the United Nations Development Programme

The General Assembly

<u>Takes note</u> of the reports of the Governing Council of the United Nations Development Programme on its seventh and eighth sessions. $5^{/}$

DRAFT RESOLUTION II

Procedures for implementation of new arrangements for regional and inter-regional projects under the Technical Assistance component of the United Nations Development Programme

The General Assembly,

<u>Having considered</u> the report of the Governing Council of the United Nations Development Programme on its eighth session^{6/} and Economic and Social Council resolution 1432 (XLVII) of 25 July 1969 concerning the revised programming procedures for regional and inter-regional projects for the Technical Assistance component of the Programme,

<u>Recalling</u> its resolution 2279 (XXII) of 4 December 1967 concerning the new programming procedures for the Technical Assistance component of the Programme,

<u>Approves</u> the procedures recommended by the Governing Council of the United Nations Development Programme for regional and inter-regional projects under the Technical Assistance component of the Programme beginning with the year 1971.^{T/}

DRAFT RESOLUTION III

Programming and budgetary procedures for the United Nations regular programme of technical co-operation

The General Assembly,

<u>Having considered</u> chapter X, section B, of the report of the Economic and Social Council^{8/} dealing with the technical co-operation activities undertaken by the Secretary-General of the United Nations,

<u>Having reviewed</u> the notes by the Secretary-General on operational activities for development undertaken by him and on the United Nations Industrial Development Organization,^{9/}

<u>Having noted</u> resolution 1434 (XLVII) of 25 July 1969 of the Economic and Social Council recommending revised programming and budgetary procedures for the United Nations regular programme of technical co-operation,

<u>Keeping in mind</u> General Assembly resolution _____(XXIV) on the regular programme of technical assistance for industrial development, which reaffirmed its resolution 2298 (XXII) of 12 December 1967 providing for programming and budgetary procedures for the regular programme of technical assistance in the field of industrial development,

<u>Approves</u> the application of the programming and budgetary procedures contained in Economic and Social Council resolution 1434 (XLVII) to the United Nations technical co-operation activities other than industrial development, which is provided for under part V (Technical programmes) of the United Nations budget.
