OF ALGERIA FOR ADMISSION TO MEMBERSHIP IN THE  
UNITED NATIONS

Cable dated 30 September 1962 from the Head of Government  
of the Democratic and Popular Republic of Algeria addressed  
to the Secretary-General

Note by the Secretary-General: Pursuant to rule 136 of the rules of procedure of the General Assembly, the Secretary-General has the honour to transmit herewith, for the information of the Members of the United Nations, a copy of a cable addressed to him on 30 September 1962 by the Head of Government of the Democratic and Popular Republic of Algeria with regard to the application of the Democratic and Popular Republic of Algeria for admission to membership in the United Nations.

ON BEHALF OF THE ALGERIAN GOVERNMENT AND IN MY CAPACITY AS HEAD OF GOVERNMENT OF THE DEMOCRATIC AND POPULAR REPUBLIC OF ALGERIA, I HAVE THE HONOUR TO INFORM YOU THAT ALGERIA, HAVING ATTAINED INDEPENDENCE, HEREWITH APPLIES FOR ADMISSION TO MEMBERSHIP IN THE UNITED NATIONS, WITH ALL THE RIGHTS AND DUTIES ATTACHING THERETO. I SHOULD BE GRATEFUL IF YOU WOULD BE GOOD ENOUGH TO SUBMIT THIS APPLICATION TO THE SECURITY COUNCIL AT ITS NEXT MEETING. FOR THAT PURPOSE, I AM ENCLOSING A DECLARATION MADE IN PURSUANCE OF RULE 58 OF THE COUNCIL'S RULES OF PROCEDURE. ACCEPT, SIR, THE ASSURANCES OF MY HIGHEST CONSIDERATION.

## DECLARATION

IN CONNEXION WITH ALGERIA'S APPLICATION FOR ADMISSION TO MEMBERSHIP IN THE UNITED NATIONS, I HAVE THE HONOUR TO DECLARE, ON BEHALF OF THE ALGERIAN GOVERNMENT AND IN MY CAPACITY AS HEAD OF GOVERNMENT OF THE DEMOCRATIC AND POPULAR REPUBLIC OF ALGERIA, THAT ALGERIA HEREBY ACCEPTS THE OBLIGATIONS OF THE UNITED NATIONS CHARTER AND SOLEMNLY UNDERTAKES TO FULFIL THEM.
