Report of the Fifth Committee

Rapporteur: Mr. N.A. QUAO (Ghana)

- 1. At its 949th meeting, held on 15 November 1962, the Fifth Committee considered a note by the Secretary-General (A/5156) concerning the vacancies which will occur in the membership of the Committee on Contributions as a result of the expiration of the terms of office of three of its members on 31 December 1962.
- 2. The members of the Fifth Committee had previously been invited to suggest the names of persons who might be recommended to the General Assembly for appointment to the Committee on Contributions in accordance with the provisions of rule 160 of the rules of procedure of the Assembly. At the time the matter was considered by the Fifth Committee, three names had been proposed in respect of the abovementioned vacancies.
- 3. To decide who should be recommended for appointment, the Committee voted by secret ballot. The result of the ballot was as follows:
