Report of the Secretary-General

Addendum

1. In his report of 2 October 1962 (A/5249), the Secretary-General indicated the measures taken by him in pursuance of operative paragraph 3 of General Assembly resolution 1698 (XVI) of 19 December 1961 to produce and disseminate information material relating to the resolution. Tables showing the progress made in these measures by the end of September 1962 were contained in annexes I and II to the report.

ANNEX II

STATUS OF DISSEMINATION OF THE RADIO TALK ON THE
RESOLUTION ON RACIAL DISCRIMINATION IN NON-SELF-
GOVERNING TERRITORIES (1698 (XVI))

1. Production of a special radio talk in Malay on the resolution on racial discrimination in Non-Self-Governing Territories has been completed through the United Nations Information Officer in Bangkok. Distribution of the talk in Malay has been made directly to radio stations in Brunei, North Borneo, Sarawak and Singapore, with a request for assistance in securing translations for broadcasting in local languages.
2. The special talk on racial discrimination has also been distributed in French and Hindi as well as in English directly to radio stations in Mauritius.
