UNITED NATIONS INSTITUTE FOR TRAINING AND RESEARCH: REPORTS OF THE SECRETARY-GENERAL

Report of the Second Committee

Rapporteur: Mr. A. RAMAHOLIMIHASO (Madagascar)

- 1. At its 1336th plenary meeting, on 24 September 1965, the General Assembly allocated to the Second Committee agenda item 48 entitled "United Nations Institute for Training and Research: reports of the Secretary-General".
- 2. The Committee considered this item at its 987th and 992nd meetings on 17 and 25 November 1965.
- 3. In considering the item, the Committee had before it a report of the Secretary-General (A/6027), two progress reports of the Secretary-General to the Economic and Social Council at its thirty-seventh and thirty-ninth sessions (E/3924, E/4049) and the reports of the Economic and Social Council to the General Assembly at its nineteenth and twentieth sessions. $\frac{1}{2}$
- 4. The Executive Director of the United Nations Institute for Training and Research addressed the Committee at its 987th meeting, when the Committee began its consideration of this item; the text of his statement will be found in document A/C.2/L.817.
- 5. At the same meeting, <u>Bolivia</u>, <u>Canada</u>, <u>Costa Rica</u>, <u>Denmark</u>, <u>Guinea</u>, <u>India</u>, <u>Jamaica</u>, <u>Jordan</u>, <u>Panama</u> and <u>Uganda</u> submitted a draft resolution (A/C.2/L.816), which read as follows:

"The General Assembly,

"Recalling its resolutions 1827 (XVII) and 1934 (XVIII) relating to the United Nations Institute for Training and Research,

"Having continued the examination of that Institute's position,

"Noting with interest the progress made so far in establishing the Institute's preliminary activities,

"Taking note of Economic and Social Council resolutions 1037 (XXXVII) and 1072 $\overline{(XXXIX)}$, and of the reports submitted by the Secretary-General and the statement made by the Executive Director of the Institute, 2/

- "1. Expresses the hope that the Institute will begin its regular operations as soon as possible and not later than the end of 1965;
- "2. Renews its appeal to Governments of States Members of the United Nations or members of the specialized agencies and the International Atomic Energy Agency and private institutions which have not yet financially contributed to the Institute to give it their generous financial support now that it has been established."
- 6. <u>Hungary</u> submitted an amendment (A/C.2/L.821) to add the following new paragraph at the end of the ten-Power draft resolution:
 - "3. Instructs the Executive Director of the Institute to report on the activities of the Institute annually to the Economic and Social Council."

At the 992nd meeting, the representative of Hungary revised his amendment to read:

- "3. Requests the Executive Director of the Institute to report annually on the activities of the Institute, as appropriate to the Economic and Social Council, and to the General Assembly."
- 7. The co-sponsors of the draft resolution accepted the amendment of Hungary, as orally revised. In addition, they deleted the second paragraph of the preamble of the draft resolution.
- 8. Algeria and Senegal became co-sponsors of the draft resolution, as revised.
- 9. At the 992nd meeting, the Committee voted on the draft resolution, as orally revised, and approved it unanimously.

RECOMMENDATION OF THE SECOND COMMITTEE

10. The Second Committee therefore recommends to the General Assembly the adoption of the following draft resolution:

United Nations Institute for Training and Research

The General Assembly,

Recalling its resolutions 1827 (XVII) of 18 December 1962 and 1934 (XVIII) of 11 December 1963 relating to the United Nations Institute for Training and Research,

Noting with interest the progress made so far in establishing the Institute's preliminary activities,

Taking note of Economic and Social Council resolutions 1037 (XXXVII) of 15 August 1964 and 1072 (XXXIX) of 26 July 1965, and of the reports submitted by the Secretary-General and the statement made by the Executive Director of the Institute, $\frac{3}{2}$

- 1. Expresses the hope that the United Nations Institute for Training and Research will begin its regular operations as soon as possible and not later than the end of 1965;
- 2. Renews its appeal to Governments of States Members of the United Nations and members of the specialized agencies and of the International Atomic Energy Agency and to private institutions which have not yet financially contributed to the Institute to give it their generous financial support now that it has been established:
- 3. Requests the Executive Director of the Institute to report annually to the Jeneral Assembly and, as appropriate, to the Economic and Social Council on the activities of the Institute.
