Report of the 2016 United Nations/Food and Agriculture Organization of the United Nations Pledging Conference for the World Food Programme

A. Opening and duration of the session

1. The Conference was held at United Nations Headquarters on 7 November 2016.
2. The Conference was opened by the Chief of the Development Cooperation Policy Branch at the Office for Economic and Social Council Support and Coordination of the Department of Economic and Social Affairs.

B. Attendance
