INFORMATION FROM NON-SELF-GOVERNING TERRITORIES TRANSMITTED UNDER ARTICLE 73 e OF THE CHARTER OF THE UNITED NATIONS

Report of the Secretary-General

- 1. Under the terms of Article 73 e of the Charter, Member States which have or assume responsibilities for the administration of Territories whose peoples have not yet attained a full measure of self-government undertake to transmit regularly to the Secretary-General information relating to economic, social and educational conditions in the territories for which they are responsible, other than those Territories to which the International Trusteeship System applies. In addition, the General Assembly in several resolutions, the most recent of which was resolution 2109 (XX) of 21 December 1965, has variously invited and urged them to transmit, or continue to transmit, information as prescribed under Article 73 e of the Charter, as well as the fullest possible information on political and constitutional development in the Territories concerned.
- 2. The table annexed to the present report shows the dates on which the information called for in Article 73 e was transmitted to the Secretary-General in respect of the years 1964 and 1965. The table includes all information received up to 1 December 1966.
- 3. The information transmitted under Article 73 e follows in general the Standard Form approved by the General Assembly and includes information on geography, history, population and economic, social and educational conditions. In the case of Territories under the administration of Australia, New Zealand and the United States of America, the annual reports of the Territories, which also include information on constitutional matters, were transmitted. information on political and constitutional developments in Territories under their administration were also given by the representatives of Australia, New Zealand, Spain, the United Kingdom of Great Britain and Northern Ireland and the United States of America during meetings of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples.

4. No information has been transmitted to the Secretary-General concerning Territories under Portuguese administration, which the General Assembly decided in resolution 1542 (XV) of 15 December 1960 to consider as Non-Self-Governing Territories within the meaning of Chapter XI of the Charter. The Secretary-General has received no information either concerning Southern Rhodesia, which, the Assembly affirmed in resolution 1747 (XVI) of 28 June 1962, was a Non-Self-Governing Territory within the meaning of Chapter XI of the Charter. 5. In operative paragraph 5 of its resolution 1970 (XVIII) of 16 December 1963 and operative paragraph 4 of its resolution 2109 (XX) of 21 December 1965, the General Assembly requested the Special Committee to study the information transmitted under Article 73 e and take it fully into account in examining the situation with regard to the implementation of the Declaration. with the procedure approved by the Special Committee in 1964, $\frac{1}{2}$ this information was taken into account by the Special Committee in its consideration of the Territories concerned and is reflected in the chapter of the Special Committee's report to the General Assembly at its current session dealing with each of these Territories (A/6300/Add.1-10). The report also contains an

account of the action taken by the Special Committee pursuant to General Assembly

resolutions 1970 (XVIII) and 2109 (XX).2/
