I. INTRODUCTION

1. The United Nations Programme of Assistance in the Teaching, Study, Dissemination and Wider Appreciation of International Law was established by the General Assembly under resolution 2099 (XX), adopted on 20 December 1965. The content of the Programme was based on the report of the Special Committee on Technical Assistance to Promote the Teaching, Study, Dissemination and Wider Appreciation of International Law, which had been set up under resolution 1968 (XVIII) to make proposals for United Nations action in this sphere. In accordance with the Special Committee's recommendations endorsed in paragraph 2 (a) of General Assembly resolution 2099 (XX), the Programme was to consist in part of:

"Steps to encourage and co-ordinate existing international law programmes carried out by States and by organizations and institutions, such as those proposed by the Special Committee in part I, section A, of its report to the General Assembly".

Among the suggestions made by the Special Committee in part I, section A, of 2. its report was that two registers should be drawn up, one containing a list of experts and the other a list of scholars in the field of international law. It was proposed that these lists or registers should contain the names and other relevant data of persons who had specialized knowledge and experience in the teaching and practice of international law and who might be available to assist developing countries. Governments of such countries would then be able to consult the lists and seek to obtain the services of persons able to provide suitable assistance. Such assistance might range, in the light of individual needs, from the establishment or improvement of international law programmes conducted in national institutions to the provision of expert advice on the practical application of international law, including the preparation of treaties and pertinent legislation. The present register has been prepared in response to the proposal made by the 3. Special Committee. The Committee suggested that the United Nations Educational, Scientific and Cultural Organization (UNESCO) might undertake the preparation of

the register of scholars and that the United Nations should prepare the register of international law experts. Having regard to the difficulty in many instances in distinguishing between these two categories it was decided, however, that the United Nations should compile a single register containing both experts and scholars, without specifying, or asking Governments to specify, whether a particular person was to be considered as a scholar or as an expert. The Secretary-General of the United Nations accordingly wrote in June 1966 to States Members of the United Nations and members of UNESCO, asking them to furnish a list of their nationals who were qualified by their experience and distinction in the field of international law to be placed on the register and who had expressed an intention of making themselves available for service in developing countries. The following register contains the replies received from States up to 1 July 1967, in response to the Secretary-General's communication. Further replies will be circulated as addenda to the present document.

- 4. Any State interested in the services of a person listed in the register should contact him directly, or through his Government, in order to negotiate the terms of his engagement. The conditions, including availability at specific times, under which individuals will be prepared to undertake service abroad may be expected to vary according to the particular circumstances; in many cases persons included in the register indicated that they would require an adequate period of notice and, in some instances, the consent of their present employer, before entering into a contract. The details as to availability, together with those relating to remuneration and other matters, are thus left to be arranged directly between the parties. It must be emphasized that the sole function of the United Nations has been to compile the register on the basis of the information supplied by States. The United Nations is unable to undertake the financing or to assure the availability of the services of individuals included in the register, nor does inclusion in the register entitle any person concerned to be considered a United Nations expert.
- 5. Entries in the register are divided according to the country of nationality and, where more than one person was proposed, according to the alphabetical order of surnames. The information regarding individuals has been edited and placed so far as possible under the following headings: name, present position, previous

posts held, other relevant information, publications, fields of special interest, education and languages. In the case of publications only the titles of books have been specifically listed, where information regarding these was supplied. As regards the field, or fields, of special interest, reference has been made only to specific topics (e.g. "law of the sea", "nationality questions") within the general sphere of international law. As regards language proficiency, those foreign languages of which the person has a knowledge have been listed, in the order of proficiency indicated by the individual. Where more than one language is used within the country or there is some other special feature, this has been reflected in the information given.
