Записка Генерального секретаря

Добавление

- 1. Во исполнение соответствующих резолюций Экономического и Социального Совета, и в частности резолюции 1986/35 от 23 мая 1986 года, Комиссия по правам человека на своей сорок шестой сессии должна избрать половину членов Подкомиссии и их заместителей, если это необходимо, срок полномочий которых истечет через два года. При этом надлежит избрать: трех членов от африканских государств; трех членов от азиатских государств; одного члена от восточноевропейских государств; трех членов от латиноамериканских государств и трех членов от западноевропейских и других государств.
- 2. В документе E/CN.4/1990/48 и Add.1 и 2 Генеральный секретарь информировал Комиссию о фамилиях выдвинутых кандидатов и их заместителей для избрания в Подкомиссию, полученных по состоянию на 6 декабря 1989 года. В этом документе также содержатся сообщенные биографические данные кандидатов и заместителей.
- 3. Фамилии дополнительных кандидатов и биографические данные были получены после 6 декабря 1989 года. В настоящем документе содержится обновленный перечень фамилий кандидатов в члены Подкомиссиии по состоянию на 25 января 1990 года. В него также включены биографические данные, которые не были воспроизведены в документе E/CN.4/1990/48 и Add.1 и 2 и/или получены после 6 декабря 1989 года (см. приложение).
- 4. Информация и фамилии кандидатов, полученные после даты подготовки настоящего документа, будут воспроизведены в добавлениях.
