APPOINTMENTS TO FILL VACANCIES IN THE MEMBERSHIP OF
SUBSIDIARY ORGANS OF THE GENERAL ASSEMBLY

ADVISORY COMMITTEE ON ADMINISTRATIVE AND BUDGETARY QUESTIONS

Report of the Fifth Committee (Part II)

Rapporteur: Mr. Ernesto C. GARRIDO (Philippines)

1. At its 1576th meeting, held on 16 October 1973, the Fifth Committee considered a note by the Secretary-General (A/9101) concerning the vacancies which will occur in the membership of the Advisory Committee on Administrative and Budgetary Questions as a result of the expiration on 31 December 1973 of the terms of office of four of its members.
2. The members of the Fifth Committee had been invited to submit the names of persons who might be recommended to the General Assembly for appointment to the Advisory Committee in accordance with rules 157 and 158 of the rules of procedure of the General Assembly. Four names were submitted for the consideration of the Committee (A/C.5/1531).
3. The Fifth Committee voted by secret ballot to decide on its recommendations. The result of the voting was as follows:

Seven other persons received a total of 13 votes.

4. Mr. Corrêa (Brazil), Mr. Mselle (United Republic of Tanzania), Mr. Raczkowski (Poland) and Mr. Ouédraogo (Upper Volta), having received the required majority, were declared recommended for appointment as members of the Advisory Committee on Administrative and Budgetary Questions for a three-year term beginning on 1 January 1974.
