EXPLANATORY MEMORANDUM

CONCERNING THE USSR PROPOSAL FOR THE INCLUSION IN THE AGENTA OF THE EIGHTH SESSION OF THE GENERAL ASSEMBLY OF THE ITEM:
"MEMORANDUM OF THE SECRETARY-GENERAL CONCERNING THE IMPLEMENTATION OF RESOLUTION 'C' OF THE GENERAL ASSEMBLY, ADOPTED ON 28 AUGUST 1953"

Under General Assembly resolution "C" of 28 August 1953, the Secretary-General was requested to notify the Central People's Government of the People's Republic of China and the Government of the People's Democratic Republic of Korea of proposals concerning the Korean question adopted at the seventh session of the General Assembly and to communicate to them the records of the debates in the General Assembly and to report as appropriate.

The Secretary General has now distributed to the delegations to the eighth session of the General Assembly a memorandum concerning the implementation of resolution "C" of 28 August 1953.

As the USSR delegation considers both this memorandum and the replies of the Central People's Government of the People's Republic of China and of the Government of the People's Democratic Republic of Korea to be of the greatest importance, it requests that the following item should be included in the agenda of the eighth session of the General Assembly:

"Memorahdum of the Secretary-General concerning the implementation of resolution 'C' of the General Assembly, adopted on 28 August 1953".
