Addendum

- 1. At its 2324th plenary meeting, on 18 December 1974, the General Assembly approved the calendar of conferences and meetings of the United Nations for 1975 contained in annex I of the Secretary-General's report (A/9768 and Corr.1), in which it was indicated that an addendum would be issued to reflect any modifications required by subsequent decisions of the General Assembly.
- 2. The present addendum reflects those modifications only in terms of those organs that have been extended and new organs established by the General Assembly as well as information which was conveyed to the Department of Conference Services after the issuance of the calendar of conferences and meetings for 1975 (annex I). Graphs are provided indicating the projected meetings at Headquarters and the United Nations Office at Geneva, by months, for 1975 (annex II).
