Report of the Fifth Committee

Rapporteur: Mr. Mahmoud OSMAN (Egypt)

1. At its 1650th meeting, on 25 October 1974, the Fifth Committee considered a note by the Secretary-General (A/9658) concerning the vacancies which will occur in the membership of the Advisory Committee on Administrative and Budgetary Questions as a result of the expiration on 31 December 1974 of the terms of office of five of its members.

2. The members of the Fifth Committee had been invited to submit the names of persons who might be recommended to the General Assembly for appointment to the Advisory Committee in accordance with rules 155 and 156 of the rules of procedure of the General Assembly. Five names were submitted for the consideration of the Committee (see A/C.5/1618).

3. The Fifth Committee voted by secret ballot to decide on its recommendation. The result of the voting was as follows:
