

## LAWS AND REGULATIONS

## PROMULGATED TO GIVE EFFECT TO THE PROVISIONS OF THE INTERNATIONAL TREATIES ON NARCOTIC DRUGS AND PSYCHOTROPIC SUBSTANCES

THE NARCOTIC DRUGS ACT CAP. 140A
THE NARCOTIC DRUGS (AMENDMENT)
REGULATIONS, 1980

The Minister in exercise of the powers conferred on her by section 18 of the Narcotic Drugs Act makes the following regulations:

- 1. These regulations may be cited as the Narcotic Drugs (Amendment) Regulations, 1980.
- 2. Regulation 2 of the Narcotic Drugs Regulations 1974, 1/ in these regulations referred to as the principal regulations, is amended by
  - (a) inserting in the appropriate alphabetical order the following:
    - "dental practitioner" has the meaning assigned to it by section 2 of the Dental Registration Act;
    - "medical practitioner" has the meaning assigned to it by section 2 of the Medical Registration Act, 2/, and
  - (b) deleting the word, "dentist" appearing in the first line of paragraph (b) and substituting the words, "dental practitioner".

- 3. Regulation 6 of the principal regulations is amended by
  - (a) renumbering sub-paragraphs (e) to (h) of paragraph (1) as sub-paragraphs (d) to (g); and
  - (b) deleting sub-paragraph (i), and substituting the following sub-paragraph and concluding words:
    - "(h) A practicing druggist; is authorised, so far as is necessary for the practice or exercise of his profession, function or employment and in his capacity as such a person, to be in possession of and to supply narcotic drugs".
- 4. Regulation 12 of the principal regulations is amended by
  - (a) deleting paragraph 2; and
  - (b) deleting the word, "dentist" appearing in the sixth line of paragraph (3) (b) and substituting the words, "dental practitioner".
- 5. Regulation 15 of the principal regulation is amended by deleting sub-paragraph (i) of paragraph 2(e) and substituting the following:
  - "(i) a dental practitioner, the words, "For dental treatment only", or".
