QUESTION OF SOUTH WEST AFRICA

ADDENDUM TO THE REPORT OF THE AD HOC COMMITTEE ON SOUTH WEST AFRICA TO THE GENERAL ASSEMBLY

- 1. Following upon the release of its report to the General Assembly (A/1901), the Ad Hoc Committee on South West Africa held its sixteenth meeting on 8 November 1951, when it examined four communications which had been received since the adoption of the report.
- 2. The General Assembly having authorized the Committee to examine petitions and any other matters relating to the Territory of South West Africa that may be transmitted to the Secretary-General, it considered the following communications addressed to the Chairman of the Committee:
 - (a) A communication dated 2 October 1951 from Saint Saviour's Church, Maspeth, N.Y.
 - (b) A communication dated 5 October 1951 from the Oxford City Liberal Association, Oxford, England.
 - (c) A communication dated 8 October 1951 from the Foreign Policy Association of Baton Rouge, Louisiana.
 - (d) A communication dated 8 October 1951 from the United Kingdom Council of the Racial Unity Movement, London.
- 3. In the case of each of these four communications the Committee decided:
 - (a) To accept these communications as petitions;
 - (b) In accordance with the procedure of the former Mandates System, to transmit the petitions to the Government of the Union of Scuth Africa for comment; and
 - (c) To include the petitions in the report to the General Assembly (see appendices I, II, III and IV).

APPENDIX I

SAINT SAVIOUR'S CHURCH, 58th Street and 57th Road Maspeth, Long Island,

2 October 1951

To the Chairman Ad Hoc Committee on South West Africa c/o The Secretary-General United Nations, New York

Be it known to all men by these presents

That we - the Rector, Wardens, and Vestrymen of Saint Saviour's Parish, Maspeth, Long Island, New York - being duly, formally and legally assembled for the regular October meeting of the Vestry of Saint Saviour's Parish have unanimously passed the following resolution and authorized the same to be conveyed to you for consideration at the Paris session of the General Assembly on 15 November 1951.

That the nations of the world have now (as never before) the responsibility of rendering effective the repeated decisions of the General Assembly in the face of the continued defiance of international law by the Union of South Africa and inthe face of all that this implies in breaking down the confidence of the African peoples in the integrity of our moral system and in the processes of law and order which the United Nations came into existence to establish in all the world - black and white alike.

That the peoples of all civilized nations have an urgent duty to make known you - and through you to their delegations - their firm determination to resist the extension of the doctrine of racial discrimination in Africa - definitely unchristian and contrary to the laws of God and of Holy Church - and the anarchy which must inevitably follow from it.

That we - the above named officers and officials of the above named Parish - in regular meeting assembled hereby officially petition the Ad Hoc Committee on South West Africa (in the light of the present situation) to definitely and once and for all put an end to the evasive tactics of the Union of South Africa at the United Nations (which cannot but upset the peace of the world either immediately or in the not too distant future), and to definitely and permanently establish the principle of international supervision and right of petition of the inhabitants of South West

South West Africa, for we are our brother's keeper.

That these things now desired and for which we are adding our petition be definitely and permanently established either by continuing the life and scope of the present committee if it be able to accomplish the object in hand, or, in the event of continued non-co-operation by the Union of South Africa, by referring the question of dealing with this aggressive conduct on the part of the Union of South Africa to the Security Council.

That the Secretary-General thoroughly investigate the matter and take definite steps re the same, because every effort so far made to ensure that one or more of the South West African tribal representatives who petitioned the United Nations should be present at the next session have utterly failed in spite of the fact that travelling expenses and hospitality have been provided for here in these United States by those fully cognizant of the vitally important implications of this grave question for the future of good government and the peace of the world in the days to come. The names of these accredited African representatives have already been conveyed to you in your official capacity as the Secretary-General and we trust that in the near future something definite and constructive may be done about the same.

That this petition of the duly elected and qualified officials of this Parish in the United States be given due and proper consideration in connection with the discussion of this very matter when the General Assembly meets in Paris in mid-November.
