ADOPTION OF THE AGENDA OF THE SIXTH REGULAR SESSION AND ALLOCATION OF ITEMS TO COMMITTEES, AND ORGANIZATION OF THE SESSION

## Report of the General Committee

The General Committee, at its 75th, 76th and 77th meetings held on 8, 9 and 10 November 1951, considered the provisional agenda (A/1870), the supplementary list of items (A/190^), requests for the inclusion of additional items (A/1938, A/1941, A/1943, A/1944, A/1946) and the allocation of agenda items to committees. The Committee also considered a memorandum of the Secretary-General on the organization of the session (A/BUR/125).

#### I. ADOPTION OF THE AGENDA

1. The General Committee considered that certain items on the provisional agenda and the supplementary list relating to the same question could usefully be grouped together or combined under a single item. The General Committee therefore decided to recommend to the General Assembly:

(i) To add, with a minor drafting change, item 2 of the supplementary list as point (f) under item 42 of the provisional agenda, the combined item to read

"Appointments to fill vacancies in the membership of subsidiary bodies of the General Assembly:

"(a) Advisory Committee on Administrative and Budgetary Questions

- "(b) Committee on Contributions
- "(c) Board of Auditors
- "(d) Investments Committee: confirmation of the appointment made by the Secretary General

- "(f) United Nations Staff Pension Committee".
- (ii) To combine items 4 and 9 of the supplementary list as follows: "Admission of new Members, including the right of candidate States

to present proof of the conditions required under Article 4 of the Oharter".

2. The General Committee decided to recommend the deletion of point (d) "Other related questions" under item 26 of the provisional agenda "Economic development of under-developed countries: report of the Economic and Social Council". Any "other related questions" apart from those mentioned under (a), (b) and (c) of item 26 would be covered by item 11 of the provisional agenda "Report of the Economic and Social Council", the chapters of which will be allocated to the Committees of the Assembly as appropriate according to their subject matter.

3. The General Committee approved a recommendation by the Secretary-General that item 48 of the provisional agenda "Status of claims for injuries incurred in the service of the United Nations: report of the Secretary-General" be not included in the agenda of the sixth session. All Members of the Assembly having been informed of the status of claims by a report of the Secretary-General, already circulated as document A/1851, the General Committee considers that this item need not appear on the agenda of the session unless a Member should request a debate thereon.

4. The General Committee decided to recommond to the General Assembly the deletion of point (c) "Draft code of offences against peace and security of mankind" under item 50 of the provisional agenda "Report of the International Law Commission covering the work of its third session," and to recommend the inclusion of this item in the provisional agenda of the seventh session.

5. The General Committee decided to recommend to the General Assembly that consideration of the question of placing item 6 of the supplementary list "Complaint of violation by France in Morocco of the Principles of the Charter and the Declaration of Human Rights" on the final agenda of the General Assembly be postponed for the time being.

6. With regard to the request for the inclusion of the additional item "The representation of China in the United Nations" (A/1941), the General Committee adopted the following resolution:

#### "The General Committee

"<u>Considering</u> that the General Assembly at its fifth session determined that it did not wish to take action on the question of Chinese representation without serious consideration and for that purpose established a committee to consider the question and to make a recommendation to the General Assembly.

"<u>Considering</u> that as recently as 5 November 1951, at the end of the fifth session of the General Assembly, the General Assembly expressed its desire not to refer the matter for consideration to the sixth session, thereby expressing the sense of the General Assembly that the consideration of this question is not opportune or appropriate,

"Recommends that the General Assembly decide to reject the request of the Soviet Union for the inclusion in the agenda of the sixth session of the General Assembly of the additional item entitled "The representation of China in the United Nations"; and

"Recommends that the General Assembly decide to postpone consideration, for the duration of the meeting in Paris of the sixth regular session, of any further proposals to exclude representatives of the National Government of China from the Assembly or to seat representatives of the Central People's Government of the People's Republic of China to represent China in the Assembly".

7. Taking the above decisions into account, the General Committee recommends to the General Assembly the adoption of the following agenda:

### IV. ORGANIZATION OF THE SIXTH REGULAR SESSION OF THE GENERAL ASSEMBLY

10. On the proposal of the Secretary-General, the General Committee recommends that the General Assembly approve the following arrangements relating to the schedule of meetings:

(a) That both plenary and Committee meetings shall begin at 10.30 a.m. and 3.00 p.m.

(b) That a six-day working week be established, and that normally on Saturdays one extended meeting be scheduled for Committees from 10.30 a.m. to 2.00 p.m.

- 11. On the proposal of the Secretary-General, the General Committee recommends that the Christmas recess should extend from 23 to 27 December inclusive, it being understood that 1 January 1952 will be an official holiday.
- 12. On the proposal of the Secretary-General, the General Committee recommends that the General Assembly approve, in accordance with rule 2 of the rules of procedure of the General Assembly, 26 January 1952 as the target date for the closing of the sixth session.
