Note verbale dated 21 June 1985 from the Permanent Mission of Mongolia
to the United Nations addressed to the Secretary-General

The Permanent Mission of the Mongolian People's Republic to the United Nations has the honour to transmit to the Secretary-General of the United Nations for deposit the instrument of acceptance of the Constitution of the United Nations Industrial Development Organization (UNIDO) by the Government of the Mongolian People's Republic, dated 3 June 1985.

The Permanent Mission of the Mongolian People's Republic is hereby empowered to bring to the attention of the Secretary-General of the United Nations the following observations of the Government of the Mongolian People's Republic on the activities of UNIDO.

The Mongolian People's Republic has always attached, and continues to attach, great significance to the activities of the United Nations in the field of industrial development. For this reason, it supports the proposal to convert UNIDO into a specialized agency of the United Nations, on the understanding that this step will enhance its capability for the promotion of industrial development and for the attainment and consolidation of the economic independence of the developing countries on the basis of the progressive provisions and principles of the Charter of Economic Rights and Duties of States, the Declaration on the Establishment of a New International Economic Order, the Lima Declaration on Industrial Development and Co-operation and the New Delhi Declaration on Industrialization of Developing Countries and International Co-operation for their Industrial Development.

In supporting UNIDO as a specialized agency of the United Nations, the Government of the Mongolian People's Republic considers that, for the full attainment of the purposes and the performance of the functions specified in the Constitution, UNIDO should actively promote a radical restructuring of the existing system of unjust international economic relations; the introduction of progressive social and economic transformations; the strengthening of the State sector of the economy; and the implementation of national plans and programmes of social and economic development.

UNIDO must oppose any form of economic aggression, diktat, blackmail, interference in the internal affairs of States and neo-colonialist exploitation of the developing countries practised by the forces of imperialism and in particular by the transnational corporations.

UNIDO is also called upon to promote the solution of the key problems of today - the establishment and strengthening of international peace and security and the adoption of practical disarmament measures, which will release additional resources for the development of the developing countries.

In the light of the above considerations, the Mongolian People's Republic is prepared to support the activities of UNIDO and the development of co-operation between its member countries. It is confident that the fruitful co-operation between the Mongolian People's Republic and UNIDO which has already existed for many years will be further expanded.

The Permanent Mission of the Mongolian People's Republic to the United Nations requests the Secretary-General of the United Nations to circulate this letter as an official document of the General Assembly, under items 12 and 84 of the provisional agenda and of the Economic and Social Council, under agenda item 12 of its second regular session of 1985.
