Letter dated 22 August 1985 from the Chargé d'affaires a.i. of  
the Permanent Mission of Afghanistan to the United Nations  
addressed to the Secretary-General

I have the honour to inform you that the Chargé d'affaires of the Pakistan Embassy in Kabul was summoned to the Ministry of Foreign Affairs of the Democratic Republic of Afghanistan at 10 a.m. on 21 August 1985 and the following was pointed out to him by the Director of the First Political Department:

"The militaristic Government of Pakistan, in connection with its baseless accusations against the Democratic Republic of Afghanistan, has once again alleged that on 19 August 1985 air aggression by the military forces of the

Democratic Republic of Afghanistan took place on the Khawas Keli area near Para Chenar. The Government of the Democratic Republic of Afghanistan, after thorough investigation, considers the allegation of the militaristic Government of Pakistan to be devoid of fact and decisively rejects it. It points out that the Pakistan authorities should terminate their false and baseless allegations against the Democratic Republic of Afghanistan."

I have further the honour to request Your Excellency to arrange for the circulation of this letter as a document of the General Assembly, under items 72, 73, 132, 133 and 138 of the preliminary list, and of the Security Council.
