REPORT BY THE SECRETARY-GENERAL CONCERNING THE CREDENTIALS OF THE REPRESENTATIVES AND DEPUTY AND ALTERNATE REPRESENTATIVES OF THE MEMBERS OF THE SECURITY COUNCIL ELECTED FOR THE PERIOD 1990-1991

At its 34th meeting, on 18 October 1989, the General Assembly elected Côte d'Ivoire, Cuba, Democratic Yemen, Romania and Zaire as non-permanent members of the Security Council for a term of two years, beginning on 1 January 1990.

Pursuant to rule 15 of the provisional rules of procedure of the Security Council, the Secretary-General wishes to report that, with regard to the representation of the members of the Security Council elected for the period 1990-1991, he has received the communications referred to hereunder.

Côte d'Ivoire. Credentials from the President of the Republic of Côte d'Ivoire signed on 11 December 1989 stating that Mr. Amara Essy has been appointed representative of Côte d'Ivoire on the Security Council, Mr. N'zi Nanan Koliabo Anet deputy representative and Mrs. Djénébou Kaba neé Camara, Mr. Emmanuel Amon, Mr. Djabia Joachim Anvire, Mr. Kouassi Florent Ekra and Mr. Marc Sery alternative representatives.

In the opinion of the Secretary-General, these credentials are in order.

Cuba. Credentials signed on 8 November 1989 by the Minister for Foreign Affairs a.i. of Cuba stating that Mr. Oscar Oramas Oliva has been appointed representative of Cuba on the Security Council, Mrs. María de los Angeles Flórez Prida deputy representative and Mr. Abelardo Moreno Fernández alternative representative.

In the opinion of the Secretary-General, these credentials are in order.

Democratic Yemen. Credentials signed on 2 November 1989 by the Minister for Foreign Affairs of Democratic Yemen stating that Mr. Abdalla Saleh Al-Ashtal has been appointed representative of Democratic Yemen on the Security Council, Mr. Hussein Saeed Al-Alfi deputy representative and Mr. Nabil Khaled Missary and Mr. Abdulrahman Salem Bin Brek alternate representatives.

In the opinion of the Secretary-General, these credentials are in order.

Romania. Credentials signed on 1 December 1989 by the Minister for Foreign Affairs of Romania and confirmed in a telegram dated 29 December 1989 from the Minister for Foreign Affairs of Romania stating that Mr. Petre Tanasie has been appointed representative of Romania on the Security Council, Mr. Ioan Voicu deputy representative and Mr. Nicolae Ionescu and Mr. Dumitru Tanasa alternate representatives.

In the opinion of the Secretary-General, these credentials are in order.

Zaire. Credentials from the President of the Republic of Zaire signed on 11 December 1989 stating that Mr. Adeito Nzengeya Bagbeni has been appointed representative of Zaire on the Security Council, Mr. Khabuji Lukabu deputy representative and Mr. Ngovuka Kibidi alternate representative.
