HUMAN RIGHTS QUESTIONS

Report of the Second (Social) Committee (Part I)

- 1. The Second (Social) Committee considered human rights questions (agenda item 3) at its 12th to ____ meetings, from 15 to ____ May 1990. It had before it the following documents:
- (a) Report of the Secretary-General on measures to be taken against Nazi, Fascist and neo-Fascist activities and all other forms of totalitarian ideologies and practices based on <u>apartheid</u>, racial discrimination and racism, and the systematic denial of human rights and fundamental freedoms (A/45/170-E/1990/32);

- 2. At its 12th to 16th meetings, the Committee held a general discussion on the item. At its 12th meeting, on 15 May, the Committee heard an introductory statement by the Deputy Director of the Centre for Human Rights.
- 3. Also at the 12th meeting, statements were made by the representatives of Ireland (on behalf of the States Members of the United Nations that are members of the European Economic Community), the United States of America, France,

Czechoslovakia, the Union of Soviet Socialist Republics and Mexico and the observers for Chile and Egypt.

- 4. At the 13th meeting, on 16 May, the Rapporteur of the Committee on Economic, Social and Cultural Rights made a statement.
- 5. Also at the 13th meeting, statements were made by the representatives of Canada, the Ukrainian Soviet Socialist Republic, the German Democratic Republic and Cuba and by the observers for Denmark (on behalf of the Nordic countries), the Byelorussian Soviet Socialist Republic, Myanmar and Viet Nam. The observer for the International Confederation of Free Trade Unions, a non-governmental organization in consultative status with the Council, category I, also made a statement.
- 6. At the 14th meeting, on 16 May, statements were made by the representatives of Yugoslavia and by the observers for Mongolia, Australia, the Philippines and Nigeria. The observer for the World Federation of Trade Unions and the World Muslim Congress, non-governmental organizations in consultative status with the Council, category I, also made statements.
- 7. At the 15th meeting, on 17 May, statements were made by the representatives of Guinea, New Zealand, China, Brazil and Bulgaria and by the observers for Sri Lanka, Lebanon, Hungary, Peru, Norway, Argentina, Romania and Poland.
- 8. At the 16th meeting, on 17 May, statements were made by the representatives of Algeria, Sweden, Indonesia, Nicaragua, Pakistan, Japan, Venezuela, Iraq, Cuba, India and Greece and by the observers for Cambodia, the Byelorussian Soviet Socialist Republic, El Salvador and Cyprus.

Recommendations contained in the report of the Commission on Human Rights

9. Chapter I of the report of the Commission on Human Rights on its forty-sixth session (E/1990/22 and Corr.1) contained 9 draft resolutions and 29 draft decisions recommended for adoption by the Council. Programme budget implications of the Proposals were set out in annex III to the addendum to the report (E/1990/22/Add.1).

Adverse consequences for the enjoyment of human rights of political, military, economic and other forms of assistance given to the racist and colonialist régime of South Africa

10. At the 17th meeting, on 18 May, the Committee adopted draft resolution I, entitled "Adverse consequences for the enjoyment of human rights of political, military, economic and other forms of assistance given to the racist and colonialist régime of South Africa", by a recorded vote of 32 to 7, with 7 abstentions (see para. 61 below, draft resolution I). The voting was as follows: 3/

<u>Use of mercenaries as a means of impeding the exercise of the right of peoples to self-determination</u>

19. At the 17th meeting, on 18 May, the Committee adopted draft decision 1, entitled "Use of mercenaries as a means of impeding the exercise of the right of peoples to self-determination" by a recorded vote of 33 to 3, with 11 abstentions (see para. 62 below, draft decision I). The voting was as follows: 4/

DRAFT DECISION V

Computerization of the work of human rights treaty-monitoring bodies in relation to reporting systems

DRAFT DECISION XIX

Sale of children

The Economic and Social Council, noting Commission on Human Rights resolution 1990/68 of 7 March 1990, requests the Chairman of the Commission to appoint for a period of two years a Special Rapporteur to consider matters relating to the sale of children, child prostitution and child pornography, including the problem of the adoption of children for commercial purposes, and also approves the Commission's request to the Secretary-General to give the Special Rapporteur any necessary assistance.

DRAFT DECISION XXVII

International year for the world's indigenous people

The Economic and Social Council, noting Commission on Human Rights decision 1990/113 of 7 March 1990, decides to recommend that the General Assembly proclaim an international year for the world's indigenous people in 1993, in accordance with established procedures governing the proclamation of international years.
