- a/ An additional D-l post is outposted from the Economic, Social and Human Rights Section of the Budget Division, Office of Financial Services, as shown in table 28 B.8 of the Secretary-General's proposed programme budget for the biennium 1980-1981 (A/34/6), for the purpose of supervising the financial management and budgetary control functions related to technical co-operation activities.
- 11. Appendix. Under the column for "revaluation of 1978-1979 resources" against Ad Hoc Expert Group object replace 2.5 by 2.4. (English text only.)
- 12. Appendix. Under the column for total increase for the object Hospitality replace 1.1 by 0.1.
