Note by the Secretary-General

1. The Secretary-General has been notified of the resignation from membership in the Committee on Contributions of Mr. Carlos Moreira Garcia (Brazil). It is, therefore, necessary for the General Assembly at the current session to appoint a member who would serve for the unexpired portion of Mr. Garcia's term, i.e., until 31 December 1980.
