SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE REACHED IN THEIR CONSIDERATION

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

The list of items of which the Security Council is seized is contained in document S/21100 of 24 January 1990, S/21100/Add.2 of 2 February 1990, S/21100/Add.5 of 16 February 1990, S/21100/Add.21 of 7 June 1990 and S/21100/Add.30 of 10 August 1990.

During the week ending 11 August 1990, the Security Council took action on the following item:

The situation between Iraq and Kuwait (see S/21100/Add.30)

The Security Council resumed its consideration of the item at its 2933rd meeting, held on 6 August 1990, having before it the draft resolution submitted by Canada, Colombia, Côte d'Ivoire, Ethiopia, Finland, France, Malaysia, the United Kingdom of Great Britain and Northern Ireland, the United States of America and Zaire (S/21441).

At the same meeting the Security Council proceeded to vote on the draft resolution, and adopted it by 13 votes in favour to none against, with 2 abstentions (Cuba and Yemen), as resolution 661 (1990).

Resolution 661 (1990) reads as follows:

The Security Council,

Reaffirming its resolution 660 (1990) of 2 August 1990,

Deeply concerned that that resolution has not been implemented and that the invasion by Iraq of Kuwait continues with further loss of human life and material destruction,

<u>Determined</u> to bring the invasion and occupation of Kuwait by Iraq to an end and to restore the sovereignty, independence and territorial integrity of Kuwait,

Noting that the legitimate Government of Kuwait has expressed its readiness to comply with resolution 660 (1990).

Mindful of its responsibilities under the Charter of the United Nations for the maintenance of international peace and security,

Affirming the inherent right of individual or collective self-defence, in response to the armed attack by Iraq against Kuwait, in accordance with Article 51 of the Charter,

Acting under Chapter VII of the Charter of the United Nations,

- 1. <u>Determines</u> that Iraq so far has failed to comply with paragraph 2 of resolution 660 (1990) and has usurped the authority of the legitimate Government of Kuwait;
- 2. <u>Decides</u>, as a consequence, to take the following measures to secure compliance of Iraq with paragraph 2 of resolution 660 (1990) and to restore the authority of the legitimate Government of Kuwait;
 - 3. Decides that all States shall prevent:
- (a) The import into their territories of all commodities and products originating in Iraq or Kuwait exported therefrom after the date of the present resolution;
- (b) Any activities by their nationals or in their territories which would promote or are calculated to promote the export or trans-shipment of any commodities or products from Iraq or Kuwait; and any dealings by their nationals or their flag vessels or in their territories in any commodities or products originating in Iraq or Kuwait and exported therefrom after the date of the present resolution, including in particular any transfer of funds to Iraq or Kuwait for the purposes of such activities or dealings;
- (c) The sale or supply by their nationals or from their territories or using their flag vessels of any commodities or products, including weapons or any other military equipment, whether or not originating in their territories but not including supplies intended strictly for medical purposes, and, in humanitarian circumstances, foodstuffs, to any person or body in Iraq or Kuwait or to any person or body for the purposes of any business carried on in or operated from Iraq or Kuwait, and any activities by their nationals or in their territories which promote or are calculated to promote such sale or supply of such commodities or products;
- 4. <u>Decides</u> that all States shall not make available to the Government of Iraq or to any commercial, industrial or public utility undertaking in Iraq

or Kuwait, any funds or any other financial or economic resources and shall prevent their nationals and any persons within their territories from removing from their territories or otherwise making available to that Government or to any such undertaking any such funds or resources and from remitting any other funds to persons or bodies within Iraq or Kuwait, except payments exclusively for strictly medical or humanitarian purposes and, in humanitarian circumstances, foodstuffs;

- 5. <u>Calls upon</u> all States, including States non-members of the United Nations, to act strictly in accordance with the provisions of the present resolution notwithstanding any contract entered into or licence granted before the date of the present resolution;
- 6. <u>Decides</u> to establish, in accordance with rule 28 of the provisional rules of procedure of the Security Council, a Committee of the Security Council consisting of all the members of the Council, to undertake the following tasks and to report on its work to the Council with its observations and recommendations:
- (a) To examine the reports on the progress of the implementation of the present resolution which will be submitted by the Secretary-General;
- (b) To seek from all States further information regarding the action taken by them concerning the effective implementation of the provisions laid down in the present resolution;
- 7. Calls upon all States to co-operate fully with the Committee in the fulfilment of its task, including supplying such information as may be sought by the Committee in pursuance of the present resolution;
- 8. Requests the Secretary-General to provide all necessary assistance to the Committee and to make the necessary arrangements in the Secretariat for the purpose;
- 9. <u>Decides</u> that, notwithstanding paragraphs 4 through 8 above, nothing in the present resolution shall prohibit assistance to the legitimate Government of Kuwait, and calls upon all States:
- (a) To take appropriate measures to protect assets of the legitimate Government of Kuwait and its agencies;
 - (b) Not to recognize any régime set up by the occupying Power;
- 10. Requests the Secretary-General to report to the Council on the progress of the implementation of the present resolution, the first report to be submitted within thirty days;
- 11. <u>Decides</u> to keep this item on its agenda and to continue its efforts to put an early end to the invasion by Iraq.

In a letter dated 8 August 1990 addressed to the President of the Security Council (S/21469), the Permanent Representative of Kuwait to the United Nations requested that the Security Council immediately resume its consideration of the item entitled "The situation between Iraq and Kuwait" in the light of the declaration by Iraq of the purported annexation of Kuwait.

In a letter dated 8 August 1990 addressed to the President of the Security Council (S/21470), the Permanent Representatives of Bahrain, Kuwait, Oman, Qatar, Saudi Arabia and the United Arab Emirates to the United Nations urgently requested that an immediate meeting of the Security Council be convened to consider the situation between Iraq and Kuwait in the light of recent developments, most significantly the declaration by the Iraqi Revolution Command Council annexing the State of Kuwait to Iraq.

The Security Council resumed its consideration at its 2934th meeting, held on 9 August 1990, on the basis of the above requests.

At the 2934th meeting, in addition to the representatives previously invited, the President, with the consent of the Council, invited the representative of Oman, at his request, to participate in the discussion without the right to vote.

The President drew attention to the text of a draft resolution (S/21471), which had been prepared in the course of the Council's prior consultations.

The Security Council then proceeded to vote on the draft resolution and adopted it unanimously as resolution 662 (1990).

Resolution 662 (1990) reads as follows:

The Security Council,

Recalling its resolutions 660 (1990) and 661 (1990),

Gravely alarmed by the declaration by Iraq of a "comprehensive and eternal merger" with Kuwait,

<u>Demanding</u>, once again, that Iraq withdraw immediately and unconditionally all its forces to the positions in which they were located on 1 August 1990,

<u>Determined</u> to bring the occupation of Kuwait by Iraq to an end and to restore the sovereignty, independence and territorial integrity of Kuwait,

<u>Determined also</u> to restore the authority of the legitimate Government of Kuwait,

- 1. <u>Decides</u> that annexation of Kuwait by Iraq under any form and whatever pretext has no legal validity, and is considered null and void;
- Calls upon all States, international organizations and specialized agencies not to recognize that annexation, and to refrain from any action or dealing that might be interpreted as an indirect recognition of the annexation;

- 3. Further demands that Iraq rescind its actions purporting to annex Kuwait;
- 4. <u>Decides</u> to keep this item on its agenda and to continue its efforts to put an early end to the occupation.
