Addendum

1. As announced in paragraph 4 of his note dated 30 November 1979 (A/34/548), the President of the General Assembly has held the consultations described in article 3, paragraph 2, of the statute of the Joint Inspection Unit, including consultations with the President of the Economic and Social Council and with the Secretary-General in his capacity as Chairman of the Administrative Committee on Co-ordination.
